MANAGEMENT OF YOUR PERSONAL DATA

Polymeris is committed to ensure that the collection and processing of your data, carried out at the time of your membership, complies with the General Data Protection Regulation (RGPD) and the French Data Protection Act. The collection of personal data during your membership is essentially carried out to allow you to benefit from all Polymeris services:

- Directory,
- Member management (CRM database),
- Member communication (Weekly and monthly newsletters and emailing of events - maximum 3 times per week),
- Information request to Polymeris teams,
- Contact with the Polymeris network,
- Access to the MyPolymeris platform.

This information will be processed by the administrative department and the communication department. We have complied with the RGPD legal framework by implementing the following elements:

- Information on the purpose of the application form: you know what the form is for and to whom we transfer the data.
- Minimization of data: we have reduced the amount of data requested depending on the case.
- Data security: Via SSL protocol and secure database management, we maintain a high level of security on the path of your data.

For visitors with privileged access to the MyPolymeris platform, you can set up an email alert summarizing the latest content added to your member area. You can choose whether or not you want to receive it, as well as configure its content.

Request for your personal data

For any information or to exercise your rights regarding the processing of personal data managed by Polymeris, you can contact sophie.duez@polymeris.fr. As a reminder, here are all your rights under the RGPD. It is important to specify which right you wish to exercise to respond favourably.

- **Right to information:** Request information about the collection of personal data
- **Right to object:** You may object to the dissemination, transmission, or storage of data concerning you
- **Right to rectification:** Request the rectification of any of your recorded data. Please specify the data concerned in your request
- **Right to erasure:** Request the erasure of all or part of your data. You may also request the removal of content currently associated with you.
- **Right to portability:** Request the extraction of data for reuse.
- **Right to profiling:** We do not use automated profiling; all processing is done by humans.
- **Right to restrict the use of your data:** You can submit a request to stop using your data for a period of time.

Data retention period for a membership application: 10 years after the file is closed.

GENERAL CONDITIONS OF MEMBERSHIP

In accordance with current regulations, membership fees are subject to 20% VAT.

Membership renewal from one year to the next is tacit unless the member resigns (by registered letter with acknowledgement of receipt before 12/31 of the current year).

The membership fee following renewal remains unchanged, except where the following special conditions apply:

- Application of an inflation rate to all membership bands following a decision by the cluster's Bureau.
- Signature of a new membership form, at the request of the member or the cluster, agreement on a change of bracket.

LOYALTY BENEFIT:

When Polymeris was created, the Cluster Office decided to introduce a loyalty benefit in the form of a 3% discount after three consecutive years of full membership, with an additional 1% discount for each additional year. To be eligible for this discount, you must be up to date with your membership fees. Therefore, if you meet these criteria, you will benefit from it for the year 2026.

RENEWAL:

Membership is automatically renewed for a further renewable period of one year, subject to payment of the annual membership fee by the member.

In the event of subscription to PREMIUM membership, the member undertakes to comply with all the specific conditions set out below in the "PREMIUM Membership Conditions."

COMPLIANCE WITH COMPETITION RULES:

The association and its members strictly adhere to the fundamental principles of competition law:

- **Prohibition of cartels:**
Members shall refrain from any agreement or practice aimed at restricting or distorting competition, such as market sharing, price fixing, or limiting production quantities.
- **Prohibition of abuse of dominant position:**
Members shall refrain from any abusive practices (excessive prices, price discrimination, refusal to sell) that exploit a dominant position in the market.
- **Detection of infringements:**
Members accept the principle of checks by the competent authorities in the event of suspected infringements.
- **Penalties for non-compliance:**
In the event of non-compliance, penalties may be applied: warning, temporary or permanent exclusion from the association, or any other appropriate measure. The companies or individuals involved may also be held financially and legally liable.

LOSS OF MEMBERSHIP:

Membership shall be forfeited by:

- Resignation notified by registered letter addressed to the President of the Association.
- Dissolution, for any reason whatsoever, of legal entities.
- Expulsion by the Board of Directors for non-payment of dues, failure to comply with statutory or contractual obligations, or for serious reasons. In the latter case, the member concerned shall first be invited to provide explanations regarding the facts that may justify their possible expulsion and, more generally, to present their defense.

PREMIUM MEMBERSHIP CONDITIONS

Polymeris undertakes to exempt the member from the financial contributions usually applied to projects certified by the cluster and funded during the current year.

The PREMIUM member undertakes to maintain its PREMIUM status throughout the funding period for each certified project in progress.

Polymeris undertakes to co-develop and implement a specific action that meets the member's objectives on one of the cluster's strategic pillars, in agreement with the Polymeris team.

The member undertakes to subscribe to PREMIUM membership for a minimum period of two years, ensuring the continuity of services and added value.

Annual monitoring will be provided to optimally adapt services to the member's changing needs.
